- The School is not paying any charges towards using name, moto, logo or any other non-academic activities in any other situation, organization or body.
- That the School will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The School undertakes to abide by the provisions contained in the affiliation and examination bye-laws, directions issued from time to time and the law of the land.
- That the School will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the School and staff of the School.
